**SIXTH AMENDMENT TO MASTER DECLARATION OF
COVENANTS, CONDITIONS AND RESTRICTIONS**

THE PRESERVE AT LAUREL LAKE

RESIDENTIAL DEVELOPMENT GROUP, LLC, a Florida limited liability company, referred to as "the Declarant" in the Covenants recorded in O.R. Book 1107, Page 595, Public Records of Columbia County, Florida, WESTFIELD CONSTRUCTION GROUP, LLC, a Florida limited liability company, GATEWAY DEVELOPERS OF LAKE CITY, LLC, a Florida limited liability company, C.A. BOONE CONSTRUCTION, INC., a Florida corporation, and SIM-Q DEVELOPERS, LLC, a Florida limited liability company, who are the owners of all of the land described therein, do hereby amend the Master Declaration of Covenants, Conditions and Restrictions recorded in O.R. Book 1107, Page 595, and the First Amendment to Master Declaration of Covenants, Conditions and Restrictions recorded in O.R. Book 1111, Page 2004, the Second Amendment to Master Declaration of Covenants, Conditions and Restrictions recorded in O.R. Book 1121, Page 2690, the Third Amendment to Master Declaration of Covenants, Conditions and Restrictions recorded in Inst:#200712017917, the Fourth Amendment to Master Declaration of Covenants, Conditions and Restrictions recorded in Inst:#200812007004, and the Fifth Amendment to Master Declaration of Covenants, Conditions and Restrictions recorded in Inst.200812011238, O.R. Book 1152, Page 962, all of the public records of Columbia County, Florida, as follows:

AMENDMENT NO. 1: ARTICLE IX, Section 22. Clotheslines.

Clotheslines and other similar structures are to be located such that visibility from the roadways is minimized to the greatest extent feasible. To this end, they shall be located to the rear of the dwelling.

AMENDMENT NO. 2: ARTICLE IX, Section 24. Swimming Pools or Wading Pools. All swimming pools must be enclosed with fencing or screening compatible with the construction of the dwelling and any gate must be kept locked when the pool is not in use. No aboveground pools of any type are permitted.

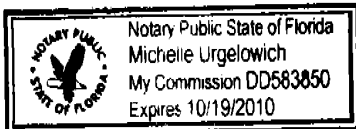

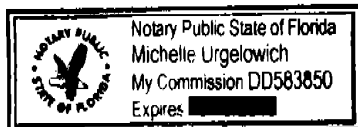
